

## Auto-tier optimisation guideline

The Auto-tier optimisation feature is a service provided by 'IndusInd Bank Ltd. for "Indus One Business" accounts only. Auto-tier optimisation means your Indus One Business Account tier automatically adjust to give you the best benefits based on your Average Quarterly Balance maintained in Current Account held with us.

- Indus One Business Account is a Dynamic 5-tier based structure with Auto-tier optimisation feature.
- The feature is available only in "Indus One Business Account" to all eligible customers who meet the criteria set by 'IndusInd Bank Ltd. for Current Account holders.
- The Auto-tier optimisation feature is activated automatically upon opening an Indus One Business Account with 'IndusInd Bank Ltd., providing customers with the benefit of optimised benefits without requiring manual intervention.
- Auto-tier optimisation features ensures that customer accounts have the flexibility to move freely between tiers automatically, aligning the benefits based on the average balance in the customer's Current Account. The pricing of specialized solutions (Merchant Services, Cash Management Services, Trade and Forex Services) also gets adjusted as per the revised tier.
- The Auto-tier optimisation is a quarterly assessment activity.
- The Account opening quarter would be excluded, will be reviewed at the end of next Quarter for Auto-tier optimisation.
- The Review will be done basis balance maintained as on 27 of the last month of quarterly review cycle.
- Based on predefined tier thresholds and corresponding benefits set by 'IndusInd Bank Ltd., the feature calculates and adjusts the account tier for the customer basis Average Quarterly Balance maintained in the last quarter.
- The feature aims to provide maximise benefits on the customer's account as the balance grown in the Current Account.
- The customers are not charged with Non-maintenance charges across the tier variants if in case the required tier specific balance is not maintained.
- Only active and operational Indus One Business Accounts will be eligible for tier changes. Any exceptions such as account freeze status, Re-KYC pending, product variant modifications, or other non-standard conditions will result in the failure of the tier change process for the quarter.
- IndusInd Bank reserves the right to modify the eligibility criteria at its discretion, with notice provided to affected customers as per regulatory requirements.
- Customers may opt out of the feature at any time by changing the product variant.
