FAQ on MP Treasury Tax Payment

General Queries

1. What is the Cyber Treasury Portal?

The Cyber Treasury Portal is an online platform by the Government of Madhya Pradesh that enables citizens, businesses, and dealers to pay various state taxes and submit e-challans digitally. The customer will have to visit the MP State Treasury Portal using the link - <https://mptreasury.gov.in/MPCTP>

2. Who can use this portal? What functions can the user perform?

Both registered and unregistered users access the portal for performing the below task:

- Submit challans
- Pay taxes
- Track payment status
- Print challans

3. Which all payment mode will be available for tax payment on MP Treasury Portal through IndusInd bank?

Below payment modes will be available on MP Treasury Portal for state tax payment:

- Online Payment (Corporate banking & Retail banking)
- Over the counter (OTC – Cash/Cheque/DD)

4. What types of taxes can be paid?

You can pay the following type of taxes:

Payment Queries

1. How do I pay tax?

- Visit the MP Treasury Portal - <https://mptreasury.gov.in/MPCTP>
- Click on Cyber Treasury Section
- Select the type of user – Registered or Unregistered
- Select the department and service that you want to pay tax for
- Enter details (Challan Form, Address, Amount and Other)
- Choose payment method
- Enter your details and complete the transaction

2. Will I receive a confirmation after payment?

Yes. You will receive:

- A CIN (Challan Identification Number)
- A downloadable challan
- SMS/email confirmation (if registered)

3. How can I track my challan history?

- **Registered users:** Log in with your credentials and go to **My Challan** to see the history

- **Unregistered users:** Use **Challan Search Report** with CIN/CRN/URN

4. How can I print an old challan if I don't have CRN or CIN?

Use the Challan Search Report feature with relevant details (date, department, amount).

5. Can I change my registered mobile number?

Yes. Log in, go to **My Profile**, and update your mobile number.

OTC Queries

1. Question: How can I make my payment in offline mode?

Answer: Offline payment can be made from branches by generating the challan through Over the counter (OTC) mode available on the portal.

2. Question: I want to print my challan for paying at the branch, but I do not have CRN or CIN what to do?

Answer: Please use challan search report option available under Cyber Treasury section by providing mandatory information.

2. Question: How can I track my previous challans?

Answer: If you are registered user then you can see your previous challans by login with your credentials and use my challan option to see the history.

3. Question: How to search challan?

Answer: Please use challan search option available under Cyber Treasury section and search using URN/CRN.

4. How much days' will challan remain active or valid in Pay at Bank Counter as an Over the Counter (OTC) mode?

Challan will be valid for 7 days from the date of challan generation. Post that user will not be able to do any action on challan.

5. Through which authorised Branch of IndusInd Bank can customer make payment for MP State Tax transaction under the "Pay at Bank Counter and under which payment modes?

The customer can make payment at any of the IndusInd Bank branches through Cash, Cheque or DD under “Pay at Bank Counter” option available on MP Treasury portal for a tax transaction.

6. Can the customer pay direct taxes through other bank cheque at Branches?

Yes, customer and even non-IndusInd Bank customer can give request at branches after generating challan under Pay at bank counter and selecting Cheque as mode.
