Grant of Stock Options under the Employee Stock Option Scheme of the Bank (ESOP Scheme)

In compliance with Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements), Regulations, 2015, we hereby inform that the Compensation Committee at its meeting held yesterday, i.e., December 30, 2020 had approved grant of 1,02,500 Stock Options (convertible into 1,02,500 Equity shares of the Bank, upon exercise) to 13 Eligible Employees in terms of the ESOP Scheme.

The main terms of the grant are mentioned below:


1. **Grant Price:** Rs.912.90 per share (Close Price on NSE on Tuesday, December 29, 2020, viz., previous day's Close Price at the Stock Exchange having the highest trading volume).
2. **Vesting Period:** 3 years from date of grant, spread at 33%, 33% and 34% at the intervals of one year from the date of grant.
3. **Exercise Period:** 5 years from date of vesting.
